Is It Safe?

No Way! This picture was taken in the headhouse of a grain elevator. According to OSHA's Grain Handling Standard 1910.272,

"The employer shall immediately remove any fugitive grain dust accumulations whenever they exceed ½ inch (.32 cm) at priority housekeeping areas."

Priority housekeeping areas include:

• Floor areas within 35 feet (10.7 m) of inside bucket elevators. Inside bucket elevator means a bucket elevator that has the boot and more than 20 percent of the total leg height (above grade or ground level) inside the grain

elevator structure. Bucket elevators with leg casings that are inside (and pass through the roofs) of rail or truck dump sheds with the remainder of the leg outside of the grain elevator structure, are not considered inside bucket elevators.

- Floors of enclosed areas containing grinding equipment.
- Floors of enclosed areas containing grain dryers located inside the facility.
